Consideration of the Continued Board of Supervisors Meeting May 31, 2018 Minutes

Mr. Tokarz noted that the field operations expenses are being allocated to all 197 platted lots regardless of ownership and the Developer will pay their fair share of any platted lots they own. Dr. Fishkind stated that the Chair reviewed the budget and is comfortable with the amounts. Dr. Fishkind requested a motion to approve the Revised Proposed Budget for FY 2018-2019.
